1 Respective responsibilities of the body and the auditor

2 External auditor report 2017/18

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR.:

The responses given in Section 1, Box 9 and Section 2, Box 11 are not consistent.

The response given in Section 2, Box 11 is not consistent with the prior year response. The Council has confirmed that it does act as sole managing trustee for trust funds and thus the answer given this year is incorrect.
